You can request us to see the identification card or CSIC certificate and ask to provide you with the CSIC Membership Identification number which is M085044. CSIC web site at www.csic.scci.ca has a full list of current CCICs. You can also call CSIC to check whether someone is registered.

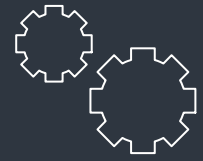
HOW MUCH SERVICE WILL COST?
